This is a document that allows a person to create and sell items from the Sheepy Soaker, Sheepy Pants, Sheepy Skirt Collection, and Sheepy Sack patterns from home for resale and profit. This license can apply to a single individual or up to 2 individuals in business together, defined as individuals selling from one website or one store, under a single business name and sharing equally in the business profits). The pattern must be purchased separately from the license. Payment can be made via PayPal or by check.

Amanda Harrington and Sheepy Time Knits, grants limited license to the LICENSEE to produce items for sale from the Sheepy Time Knits patterns, with the following conditions and requirements:

- LICENSEE agrees to pay a one time fee of \$75 to Sheepy Time Knits for a lifetime license of 4 patterns, Sheepy Pants, Sheepy Soakers, Sheepy Skirt Collection, and Sheepy Sacks. This license expires only when you cease to produce products from the pattern. This fee is non-refundable.
- The LICENSEE must produce all items in a home business capacity. Commercial production is not permitted.
- This license is not transferable.
- The LICENSEE is an independent contractor and is no way an employee of Sheepy Time Knits. Sheepy Time Knits is in no way liable for any outcome of a knitted project.
- This license is not to be construed as an outright sale. LICENSEE shall make reasonable effort to safeguard the design and interests of the LICENSOR. You may not sell or otherwise distribute the pattern.
- The following statement shall be reproduced and included with each item for sale:

This product was knitted under a special cottage industry license granted by Sheepy Time Knits.
- The LICENSEE must identify the items for sale that are produced from this pattern as Sheepy Soakers, Sheepy Pants, Sheepy Skirts, or Sheepy Sacks when they are listed for sale. If you have an auction or a store listing, it must identify this pattern, state that you are a licensed Sheepy Time Knitter, and link to <http://www.sheepytimknits.com>.
- If LICENSEE violates any of the above terms or engages in any unethical business practice, Sheepy Time Knits reserves the right to revoke this license at any time.
- Sheepy Time Knits reserves the right to refuse to sell a license to any person for any reason.
